

## BETTING GAMING AND LOTTERIES (PRESCRIBED FEES) REGULATIONS, 2013

Section 63 of the BGLA, the following Regulations are made

1. Cite as: Betting Gaming and Lotteries (Prescribed Fees) Regulations, 2013
2. Interpretation In these Regulations:

“Bookmaker’s Bet Writer’s License” - any person who receives or negotiates bets on behalf of a licensed bookmaker or bookmaker’s agent.

“Lottery Prescribed Premises” – any premises licensed by the BGLC as the head office or regional offices of a lottery promoter

“Lottery Sales Outlet” – any premises licensed by the BGLC which is used by a licensed lottery agent to receive or negotiate bets as agent of a lottery promoter

“off track terminal operator’s license” – any person duly authorised by the Racing Promoter of Off Track Betting Parlour Operator, and licensed by the BGLC, who receives or negotiates bets as na off track betting parlour

“Prescribed Premises Worker’s License” – any person employed in any prescribed premises who receives or negotiates bets on gaming machines or who is involved in the operation of the gaming machines on those prescribed premises

“Racing Promoter Terminal Operator’s Licence” – any person duly authorised by the Racing promoter and licensed by the BGLC to receive or negotiate bets on a licensed track.

3. Fees set out in Schedule shall apply and be paid on a per annum basis.
4. Fees specified in the Schedule shall be paid by the BLGC in the manner the Commission determines
