QUARTERLY GAMING INDUSTRY HIGHLIGHTS

Reporting Period: 2ND Quarter July to September 2021

This document provides an overview, key highlights and statistics for Jamaica's gaming industry for the quarter of July - September 2021.

Information presented is by sector, which includes data reported by operators licensed and regulated by the Betting Gaming and Lotteries Commission.

Betting includes bookmaking and pari-mutual wagering on horseracing (local and simulcast) and sports betting inclusive, of online casino and poker games.

Lottery comprises sales of lottery games classified as declared lottery, daily numbers game or instant lottery.

Gaming includes gaming machines (slots and locally-made gaming machines) and technical service providers.

Data presented is correct at the time of publication. However, may be adjusted without notice.

2021 | Second Quarter INDUSTRY PERFORMANCE - SALES

Total industry sales amounted to J\$36.514 billion in Q2 July 2021 to September 2021. This represented a 9.2% increase compared to the July – September 2020 quarter.

On a consecutive basis, Q2 sales decreased by 9% when compared to Q1 2021 impacted by:


• the Government COVID-19 restrictions, primarily no movement days in August and September 2021

Sales decreased in the following sectors:


- Bookmakers: local horseracing (-2%), simulcast horseracing (-28%), & Sports betting (-9%)
- Racing Promoter: simulcast horseracing (-15%)
- Lottery (-3%)
- Gaming: non-gaming lounges (operators with 19 and under gaming machines) (-34.5%).
- Gaming: gaming lounges (-3%).

Despite continued restrictions, sales increased in the following:

• Racing Promoter: local horseracing (4%)

INDUSTRY PERFORMANCE - GOVERNMENT REVENUE

Total Government Revenue for the industry was \$1.98 billion, a 1% decrease over the comparative quarter 2020. The Lottery Sector generated the highest industry sales and is the largest contributor to Government revenue which represents 92% in 2021 and 91% in the 2020 quarter.

On a consecutive basis, Q2 2021 revenue decreased by 10.3% over Q1 2021 and was impacted by no-movement days and curfew measures during the period August – September 2021. Government revenue generated by Bookmakers was significantly impacted by the no-movement days and recorded a reduction in revenue from local horseracing (-7.3%), simulcast horseracing (-22.7%) and sports betting (-28.4%).


The Racing Promoter, Supreme Ventures Racing and Entertainment Limited (SVREL) generated marginal increase in Government revenue (local horseracing, 7.6% and simulcast horseracing, 0.2%).

Revenue from the gaming sector marginally increased by 0.7%. Revenue from Gaming lounges decreased by 0.4% while revenue from non-gaming lounges increased by 18.2%. 81 slot machines were commissioned and operated in non-gaming lounges during the quarter in eight (8) parishes, mainly Kingston and St. Andrew, St. Catherine, St. James, Westmoreland, Trelawny and St. Ann.


Government revenue generated in the lottery sector decreased by 11%. Ticket sales decreased in August 2021 for all lottery games primarily due to the no-movement days and curfew restrictions. In September 2021, all lottery games decreased except for Cash Pot, Dollaz, Money Time, Hot Pick and Dream 6.


